Showman Family Story



Well, it all started many moons ago. Dad (Junior Showman) was a drag racer in the late 50s and early 60s Racing a 33 Plymouth coupe. It wasn't fancy but with dad's mechanical abilities he could take a vehicle and with junk yard parts, and a few store bought parts he could build an pretty fast car. He always brought home a trophy, jacket, or cash whenever he raced. He even raced Don Garlett's a couple times and beat him once (to Dons defense) Don had a mechanical problem that affected his performance on that race....But a win is a win.

I was only about 7 or 8 and being the oldest boy (John wasn't born yet) Dad and I would load up the car on the trailer and head to one of the tracks in the area for a day of racing, (and repairing). He also had a few neighborhood friends that would go with us on occasion (more to come on these neighborhood friends later) We would fill up with Sunoco 360 fuel, highest octane fuel we could get back then. A pound of bologna, loaf of White Wonder bread, and an 8 pack of Pepsi in the returnable glass bottles (I got to keep the bottles for the return money) it was the only way to buy sodas back then. Life was good and I still have fond memories of those days.

Well, our family grew and dad still wanted to race but also wanted to have quality time with the whole family. So, he bought his first bus. A 1946 Dodge school bus. It also wasn't pretty but dad kept it mechanically sound and converted it with everything we needed. Plywood beds, bus seat dinette, Grandmas old ice box from the early 1900s for a fridge, and many more unique (back then) things. He would load up the family, hook up the race car and head to the track. It was a great times. But the cost of racing was starting to skyrocket with new regulations, safety equipment, and speed parts, it was getting outside of the reach for the family budget. So, dad focused on the bus side of his hobby more. We even went to our first FMCA rally in Auburn Indiana, and the New York Worlds fair in 1964 in this old school bus. Meanwhile because my dad had the school bus, moms cousin had acquired a bus a 1939 Flixible Clipper (Guess who has it now?) thru a business trade. Moms' cousin got it for the new tires on it and had offered dad the rest of the bus for free. Dad had lots of time and

money in the school bus and said I don't need anything that damn big. A few months later a friend of the family (a Toledo policeman) Bob Haack came out to our house to show dad his new bus (yep, a 1939 Flxible clipper). Dad helped Bob with the repairs, conversion, and other issues. We caravanned together to our first Bus rally. To us bus rallies were not heard of. Well, we go to our first FMCA rally in Auburn Indiana 1964. We get there after dark. As we pulled in someone said hey look another Flxible. Well, when we woke up the next morning we see about 25 or so Flxible bus converted to Motorhomes. (Back then there was no such thing as a store-bought motorhome. In fact to this day FMCA still has the Flxible bus as their Company logo.

With all of these Flxible busses, and dad with this old school bus he was bitten by the Flxible bug. (Which turned into a life long illness). He made it his mission to find his own Flxible bus and convert it. We didn't even make it home from the rally and we were stopping looking at Flxible busses for sale. Every weekend thereafter we were either going to bus rally's or looking at Flxible busses. Dad finally purchased a 1945 (frog face) Flxible clipper from a church in Mount Vernon Ohio.....Just south of Loudonville.

Conversions started on this old Flxible bus and Bob Haack and dad helped each other, working on and prepping their busses for the next rally. We went many places, and saw many things as a family going to places like Travers City Michigan (where we watched Neil Armstrong take his first step on the moon on black and white TVs in front of peoples RVs), Glenwood Minnesota (where Bob Haack towed us a hundred miles with a 10 foot log chain behind the now (Dave Muller 1939 Flx.) Due to a blown engine in our bus in route.) Bowling Green Kentucky (Where dad ran a wrecker one year pulling coaches out of the mud after a torrential down pour), and Los Angeles California Burlington Vermont, and many other locations and historic places in between.

Occasionally we were slowed down by mechanically issues, but that never stopped dad. He has rebuilt engines alongside the road, fixing other people's busses alongside the road (back then you never passed another RV'er alongside the road without offering help), Dad even carried a spare engine if needed. Dad was constantly being asked to help others at these rallies to get their busses back on the road. He even gave up his spare engine at one of the FMCA conventions to put it in a friend's bus that had blown theirs on the way to the convention.

Mom and Dad were dedicated to the traveling life in their "spare time" (they still had day jobs). Mom was a school bus driver and Dad was a transmission mechanic and then a school bus mechanic.

We, as a family explored most of the USA and learned a lot in our Flxible bus.....Us kids while in school.... The teachers would discuss places in the US in history, geography, or current affairs. We would be able to say, yes we've been there, or we've done that. To us Showman kids, we thought everyone did that. We never knew how lucky we were to have parents that made it a priority to discover our great country and learn from our travels. This I am so proud of and thankful for. LOVE you MOM and DAD!!

One year Des and Patsie Feary (from Australia) came to the US and spent the summer traveling with my folks in mom and dad's coach. Mom and dad were happy showing them around our wonderful country and having them as a guest at one of the FOI rally's.

Many of our travel partners over the years have included many of the FOI members. Most notably I remember Dave Glass and his family (His kids and our family were the same ages and we loved to travel together), Gearold and Sue Meyers, Bob and Diane Cole, the whole Muller clan, Ed and Anne Eyre ... remember as I mentioned before about neighbors that used to go drag racing with dad and I, well Ed Eyer was a teenager then and was fascinated with the racing stuff and hung out at mom and dad's place in Holland Ohio learning racing and mechanic'ing.) they forged a lifelong friendship that included racing, old cars and eventually Flxible busses.

Mom and Dad were Instrumental in starting and maintaining and acting as officers in several bus related clubs and chapters over the years. These include CCO Converted Coach Owners, FOI Flxible Owners International, Midwest Coachmen (FMCA), Michigan Knights of the Highway (FMCA), Old Hounds club, and many others.

The Showman "Children" (we aint kids no more) have also been involved in keeping the Flxible Spirit and FOI alive, by serving as officers, volunteering, hosting rally's, and making new friendships in the FOI Organization.

I have been to all 48 contiguous states in my 1962 Flxible Starliner and have lots of memories and stories to tell.

Because of the wander lust and the love for travel that mom and dad created in us kids, (my brother, sisters and I) we have loved to travel and see many new things. Because of that, we have all had Flxibles of some sort and still do. The tradition lives on as our children and grandchildren have inherited this wander lust gene. My son Christopher (Mom and Dad's grandson) now has his own Flxible making 3 generations of Showman Flxibles. My son Alex and his family are avid hikers and backpackers with many miles of the Appalachian trail and other trails under their belt. And my daughter Molly and her family that have incorporated her equestrian passion and lust for travel into a wonderful lifestyle.

Thru the years Junior and Bertha and our family, have hosted several rallies including FMCA chapter Rallies, CCO rally's, and FOI rally's at Loudonville and other locations, and Also at their "Bus Farm" in Ohio

We have enjoyed (and at times cursed) these old Flxibles thru-out our lives. Below is some of the busses the Showman family have owned.
