The Flxible Rally



Dick and Betty Marsan of Methuen, Massachusetts, own a converted Flxible coach. Like many Flxible owners, they take great pride in their coach and communicate regularly with other Flxible owners. Some years back, Dick and Betty got the idea of bringing many Flxible coaches together for a rally. About two years ago Dick and Betty decided to take action and actively began contacting other Flxible owners to get them interested in such a rally. Eventually, the idea developed into the concept of bringing the coaches back to the old Flxible plant in Loudonville, Ohio, as somewhat of a pilgrimage to their birthplace.

Apparently the people of Loudonville, Ohio, also thought it was a great idea. Flxible bus manufacturing has since been transferred to Delaware, Ohio, and the Loudonville plant now does little more than manufacture component parts. Many of the older workers, however, remember those brighter days when the Loudonville plant turned out shiny new Clippers as well as VL-100's and the other larger Flxible coaches.

The rally planned by Dick and Betty took place in Loudonville from July 15-17, 1986. It turned out to be a great success in many ways. Over 25 Flxible coaches showed up to participate in the event. The oldest coach was a 1939 Clipper, and one family came all the way from Olympia, Washington, to participate. Another Flxible owner started off from California with his coach but had mechanical problems in Omaha. However, he continued on to the rally by automobile.

Each morning of the rally, the coach owners would meet for coffee and donuts, mixed with a liberal amount of socializing and Flxible discussion. The refreshments were graciously provided by Flxible. Since most active Flxibles are in use as converted coaches, most of the events took place in a campground in the Loudonville area.



The most exciting day of the Flxible rally came when the coaches were driven to the Flxible plant in Loudonville where they had originally been manufactured. Many photos were taken of the coaches "returning home" and lined up in front of the plant.

The rally got started on Tuesday morning with a flea market, giving participants an opportunity to show, swap, and sell parts and crafts. Expectedly, Flxible parts and Flxible items were very much in evidence. Tuesday ended with a dessert

social among the participants in the evening.

Wednesday was probably the highlight of the rally. The day started out with the buses getting lined up and then forming a parade to the Flxible plant. Appropriate-

of the building. a great time for the rally participants who had many laughs.

There was quite a turn out of people at the plant for this event. In addition to current Flxible employees, the crowd that morning included retired Flxible employees, many Loudonville residents, and even some newspaper reporters. The coaches were split into groups and were lined up in front of the old plant for photographs. Activity reached a peak as people formed lines to take photos of the assembled Flxibles that had "come home for a visit," while the old timers told stories of the "good old days" when the plant was still producing intercity coaches.

On Thursday, the coaches were opened to the public. In addition to Loudonville residents, many retired Flxible employees came to view the buses. The former employees remembered building the shells, but were impressed by the interior conversions to motor homes.

The rally ended on Thursday evening with a catered supper. The guest speaker was Mr. Burley Saunier, the retired fire chief of Loudonville who had worked for Flxible for over 40 years. Each coach owner was given a plaque to commemorate their participation in the event and the Flxible Corporation donated other prizes. A gift was also presented to Dick and Betty Marsan for their time and effort in planning



DIY Projects by Brad Wallace

If you are working on your bus and would like to share your experience, please take some photos and a small write up.


Here's mine, Newsletter Editor in Chief:

I started to work on a simple audio problem on my bus radio. Wanted to be able to listen to music while going down the highway. So, I purchased one of those fancy radios with 7" screen, so I can have a back up camera, maps, and more. I put the radio in and connected to the wires of the old radio, big mistake, or god send. There were circuit or continuity problems to speakers, worked at first, when to try a second time, no go. As any curious person, I started tracing wires, as you can see in the photos, no rhyme or reason to the wires, no documentation, no schematic, and wires go into a bundle

and no clue as to where it went (was it head light, defrost, whatever).

I proceeded taking the dash apart, to my surprise, wires were bare, broken, and some didn't do anything. Once I traced the different wires, mostly through process of elimination, I got all of the instrument gauges working again. Some hadn't work since we got the bus.

First, I started tagging wires with blue tape as to what I thought it was, for example; wire from the headlight switch was a great start. In many, OK all cases, I couldn't trace it to it's final place. Wirers were broken, work arounds, some of it was just plain Hokus Pokus.



This is what I started with, had to do a lot of tracing, note taking, and just figuring out what the wires were connecting.

To the right is the floor high beam switch, before and after.

Once I got all of the wiring out of the front of the bus, I was able to make one small wire harness that took care of the right side of the front of the bus, defrost, and radio. The other wire harness had to be made by pulling



each wire through the holes and trays individually. The best part was labeling each end of the wire with much more than a number. The printer I have can print onto head shrink tube with a more descriptive



notation, "To right headlight", "From relay in panel A", you get the idea. I also used some color coding of wire, but not a lot, mostly red and black.

The front panel has all of the switches and terminal post labeled,

much easier to trouble shoot. It took longer than expected, mostly because I didn't expect to go this deep. Maybe later in the summer I'll be able to tackle the rear panel and all of the lights on the back of the bus. Then, sometime in the future, wires connecting the 2 panels from the front to the back.
